1st Race in the 2010 Coldwell Banker Elite Grand Prix Series

Location: Curtis Park in Stafford County, Virginia. Please park in the large parking lot near the pool.

Registration: Cost until January 23, 2010 is \$19 and \$25 thereafter. Fee includes a long sleeve cotton T-shirt. If you don't want a T-shirt, pay only \$11 until Jan 23, 2010 or \$17 thereafter. T-shirts may not be available for runners registering after Jan 23, 2010.

Course: This 4 mile race is on an out and back USATF Certified (VA08003RT) course, running on Hartwood Rd, Royal Hills, Tracy and Jesse Curtis Ln. Course is rolling hills.

Chip Timing will be provided by Race Timing Unlimited, using Winning Time Chips. Chips will be distributed at Curtis Park starting at 9am on race day. Chips are to be worn on the right ankle. No Chip, No Time.

Awards: Top man and woman will receive \$50 gift certificates.

Age Groups: The top 3 men and women in each of the following age groups will receive an award: 19 & U, 20-24, 25-29, 30-34, 35-39 40-44, 45-49, 50-54, 55-59, 60-69 and 70 & over (mugs).

Couples Division: The top 3 couples based on lowest age and gender adjusted combined times will receive \$50 gift certificates to a local restaurant. A couple is defined as two adults (18 or over) that have been in a monogamous relationship together for at least one year.

Big Game Division: First runner wearing a jersey of the NFC Champions and first runner wearing a jersey of the AFC Champions to finish the race will receive \$50 gift certificates to a local restaurant.

Race day registration will be held from 9 to 9:45am. Please arrive early to allow yourself enough time to complete the registration process.

Packet Pick Up & Late Registration:

Race numbers and T-shirts may be picked up at VA Runner on Saturday Feb 6 (10am to 5pm) and at Curtis Park on Feb 7 (starting at 9am). Packets not picked up will not be mailed. No Refunds.

Important Information: To ensure runner safety, unregistered runners, unauthorized vehicles, bicycles, skateboards, roller skates and roller blades, baby joggers, **the wearing of headphones** and running with dogs are prohibited on the course.

Directions from I-95, exit 133 – take Route 17 North, after about 6 miles, turn right on Hartwood Rd, after 2 miles, turn right into Curtis Park.
